### What is the purpose of this update?

This document tells you how the Ranfurly Sterling Cash Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Ranfurly Strategic Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### **Description of this fund**

The Fund invests directly into an underlying cash fund. The Fund currency is Pounds Sterling (**GBP**). The objective of the Fund is to protect capital while providing liquidity by investing into Sterling cash or cash equivalents.

## What are the risks of investing?

Risk indicator for the Ranfurly Sterling Cash Fund<sup>1</sup>.

Small differences in fees and charges can have a big impact on your investment over the long term.

### Example of how this applies to an investor<sup>5</sup>

John had GBP10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, John incurred a loss after estimated fund charges were deducted of -GBP11 (that is -0.11% of his initial GBP10,000). John paid GBP0 in other charges. This gives John a total loss of -GBP11 for the year.


### **Actual investment mix**

The fund invests into underlying funds denominated in Sterling. The investments are not hedge into New Zealand Dollars, 0% hedged. The hedging policy of the fund is to not hedge the investments to give investors exposure to Sterling currency movements. The underlying funds invest into a mix of assets denominated in Sterling. The manager of the underlying fund does not hedge the underlying funds as they are held in Sterling.

#### **Notes**

- <sup>1</sup> This fund came into existence on 26 May 2017 and received its first investment on 1 September 2017 and the fund was fully redeemed on 20 October 2017 and was unitized again on the 22 June 2018 and was fully redeemed on 10 August 2018. To calculate the risk indicator, market index return data has been used for the five-year period ended 30 September 2018. Using market index return data may make the risk indicator a less reliable indicator of how much fund values are likely to go up and down in future.
- <sup>2</sup> The fund has not yet remained invested for a 12 month period.
- <sup>3</sup> The fund has not been invested for a 12 month period, so the Annual Fund Charges are calculated based on an actual assets under management and actual fees and expenses from the first unitisation of the fund on 1 September 2017 to 31 March 2018.
- <sup>4</sup> The fund has not been invested for a 12 month period, so the Annual Fund Charges are calculated based on an actual assets under management, actual fees and expenses and actual underlying fund manager fees apportioned for the period the fund has been invested, from the first unitisation of the fund on 1 September 2017 to 31 March 2018.
- <sup>5</sup> As the fund has not remained invested for a 12 month period, the example has been calculated based on the market index return less Annual Fund Charges. The impact of tax on the market index return cannot be calculated until the Scheme is invested. The Scheme invests into foreign assets where income is determined under the Fair Dividend Rate Method and is subject to tax under the Foreign Investor Zero Rate PIE tax regulations.
